Meeting Minutes

McKinney-Vento Homeless Update: No report available.

Current SR Classroom Status: CECP's SR spaces are full; there is afternoon lottery space available. CASTLE is full. Head Start has space available.

Hardship Request: Council members reviewed and approved a hardship request.

SR Classroom Monitoring and Professional Development Hours: Winter visits in progress; in person at CASTLE and videos from CECP. Planning for Spring visit to take place late April/early May, requesting in person if possible. C. Praisner confirmed that Health & Safety training can be used towards the requirement of 15 hours, and still need two early childhood development/educational topics in addition to one on diverse learners.

SR Budget Update: C. Praisner reviewed the 21-22 budget, on track for spending, programs fully funded. J. Lenares will be paid out next month for a second round of monitoring. Two Professional Development programs are scheduled. Diverse Learners workshop will take place virtually on March 30th, Math will take place on May 11th, in person. Funds in the supply line were reallocated to cover ESGI.

Review Changes to SR Selection Process: C. Praisner reviewed final changes to the process document.

SR RFP Local Applications: C. Praisner reviewed the grant submission information. Community responses were uploaded by C. Praisner. The council approved CECP and CASTLE for inclusion in the grant application.

QE Funding for FY23: C. Praisner proposed Circle of Security for the Classroom Curriculum, which includes 6-8 sessions at 1.5 hours, possibly hybrid. Program covers the importance of the role of the teacher, as the central relationship for students. Bid out for professional development topics, but did not receive any other bids.
